**NOTICE PURSUANT TO SCHEDULE 3 OF THE MAKING OF AN ARTICLE 4 DIRECTION**

We HEREBY GIVE NOTICE that on 26th August 2016 the Council made a Direction under Article 4(1) of the Town and Country Planning (General Permitted Development)(England) Order 2015 (as amended) which provided that the development of the description set out in the First Schedule below should not be carried out on the land described in the Second Schedule below unless planning permission is granted on an application made under Part III of the Town and Country Planning Act, 1990 (as amended)

FIRST SCHEDULE

The provision on land of buildings, moveable structures, works, plant or machinery required temporarily in conjunction with and for the duration of operations being or to be carried out on, in under or over that land or on land adjoining that land.

SECOND SCHEDULE

Palace Gate House, 168 High Street Odiham, Hook, Hampshire RG291NP as shown edged red on the plan attached to the direction

**DIRECTION MADE UNDER ARTICLE 4 (1)**

**WHEREAS** Hart District Council being the local planning authority for the area in which the land described in the Second Schedule is situated are satisfied that it is expedient that the development described in the First Schedule below should not be carried out on the land unless planning permission is granted upon application made under Part III of the Town and Country Planning Act 1990 (as amended) (Hereafter referred to as "The Act")

**THEREFORE** pursuant to the power granted to it by Article 4(1) of Town and Country Planning (General Permitted Development) Order 2015 as amended ("the Order") the Council hereby direct that permission granted by Schedule 2 Part 4 Class A (Temporary buildings and structures) of the Order shall not apply to the land to the extent set out in the First Schedule.

This Article 4 Direction will come into force on 26<sup>th</sup> August 2016 for 6 months unless confirmed by the said Council before the end of the 6 month period.

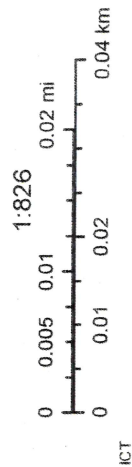
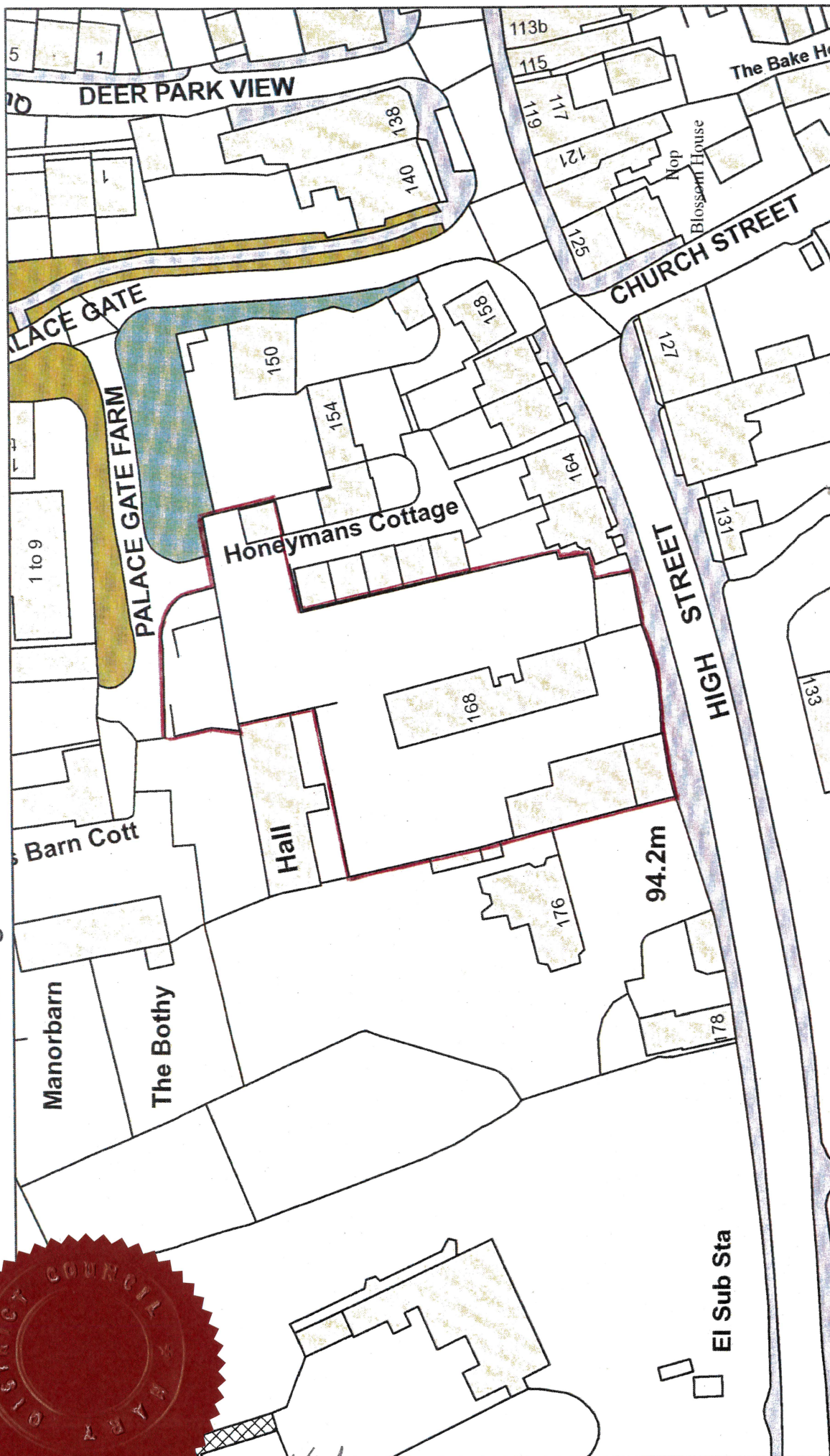
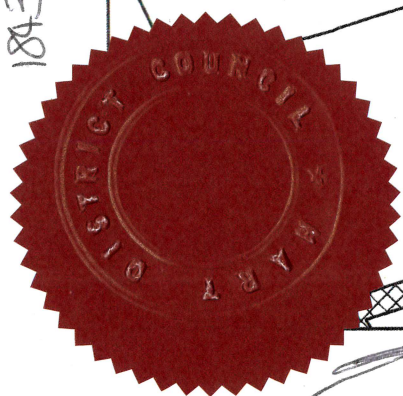
