## **Foreword**

The Council has adopted a 5-year Corporate Plan for the period 2017-2022. It provides a focus for our activities and services and will inform decision making and allocation of resources across the Council.

This Service Plan clearly outlines how we aim to meet these objectives for those who live, visit and work in Hart.

The Service Plan is structured around the Corporate Plans four priorities:


