#### **Representation:**

I am opposing the option for Site 1 in Shapley.

This site has been turned down for planning on 2 occasions in the past, with very strong reasons behind that. None of those reasons have changed, so it surprises me the site could be considered now.

Looking at the plan for Site 1 there seems to be considerable parking allocated, potentially indicating a lot of vehicle use both from the site exiting along a single lane track and then on to the A30. For traffic turning left towards Hook, will be joining at a point were the traffic speed increases downhill to 50mphl, as a local resident I can confirm the traffic is very fast there. If going right towards Hartley Wintney you have cross the A30 and join traffic already travelling up to 50 MPH.

In the past applications have been refused on the grounds of drainage and I cant see from the plans what proposal are being made for waste and storm drains. There is no mains sewer in this location.

Part of the boundary of this site is against a small copse supporting a number of trees and ponds, in particular there is a large flock of Kites that have in that are and regularly fly across from the copse to the 2 TPO trees and others in Shapley Grange. I am not sure what the impact might be for these birds and others if the building takes place and flight path hindered. There are no TP orders at Site 2.

For site 2 an area is shown for a potential Orchard and this seems to be a much better benefit to nature as there is no such thing at the Shapley option.

Any pedestrian access to and from Site 1 is difficult as the pathways bordering Site 1 are in very poor state and make walking along them unpleasant and possibly dangerous at points. One area is constantly flooded in periods of heavy or sustained

rain, forcing people to walk on to the road. No ideal if you have young children and want to walk to the village.
