# The Hart (Off-Street Parking Places) Order 2024

NOTICE IS HEREBY GIVEN that Hart District Council (the Council), pursuant to arrangements made under Section 101 of the Local Government Act 1972 with Hampshire County Council in exercise of the powers of the said County Council and in exercise of its own powers under Sections 32, 35 and Part IV of the Road Traffic Regulation Act 1984 (the Act), and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act proposes to make the following Order:-

<u>Title</u> – The title of the Order will be The Hart (Off Street Parking Places) Order 2024 (the Order)

- 8. Introducing "pay and display only "bays in the Central Courtyard car park Fleet.
- 9. Revoke The Hart (Off Street Parking Places) Order 2018.

#### The reason(s) for the Order is:

- 1. To provide a charging regime that is consistent across the whole of the district.
- 2. To generally strengthen the effective provision, management and enforcement of the Council's car parks.
- 3. Removal of the check in/out service due to low usage and cost of annual service fees.
- 4. Changes to the car park schedules (schedule 1) to enable better understanding.
- 5. Changes to "definitions and interpretations" (part B) to reflect the updated parking order.
- 6. To amend operational hours at Calthorpe Park from 5 day per week to 7 days.
- 7. To make available parking for visitors to the Council in the Central Courtyard Fleet.
- 8. To revoke The Hart (Off Street Parking Places) Order 2018

<u>Application to the High Court</u>:- Any person who desires to question the validity of the Order or any provisions contained in the Order on the grounds that it is not within the powers of Sections 1,2 and 4 of the Road Traffic Regulation Act 1984, or on the grounds that any requirement of those Sections or of Parts I,II,III or IV of Schedule 9 to the Act or any requirements made under the said Part III of Schedule 9 have not been complied with in relation to the Order may, by 8<sup>th</sup> March 2024 make application for the purpose to the High Court.
