

# Fees for Planning Services from 1 April 2025

### **Pre-application advice**

#### 1. Householder pre-application advice.

Householder developments include extensions to existing houses, conservatories, loft conversions etc.

The fees are dependent on the type of response wanted;

Response Type	Fee (incl. VAT)
Written response only	£269
Written response and a 30 minute meeting at the	£332
Council Offices	
Written response and a 30 minute meeting on site	£397

If the proposal is particularly complex and additional time is required this is charged at £134 per hour.

#### 2. Non-householder pre-application advice

Non- householder advice is for commercial properties or new or replacement residential dwellings

Proposal	Fee
Proposals of up to 50 dwellings or	25% of the equivalent application fee
floorspace of up to 3,750m2	plus VAT at 20%

- For proposals for schemes up to 9 dwellings or 999m2 of floorspace this fee will cover an initial written response and meeting of up to 2 hours.
- For proposals between 10 and 50 dwellings or between 100m2 and 3750m2 of floorspace this fee will cover an initial response and two meeting totalling no more than 4 hours in length.

If additional time is needed this can be secured at the officer hourly rates outlined in section 7 below.

For schemes over this criteria please contact us directly to discuss fees.

#### 3. Specialist Advice- i.e. Conservation, Trees

This fee (in most cases) will be in addition to the fees outlined above.

Response Type	Fee (incl. VAT)
Written response only	£297
Written response and a 30 minute meeting at the	£368
Council Offices	
Written response and a 30 minute meeting on site	£446

Please note the response type does not have match e.g. written response only from section 1 could be combined with written response and meeting on site from Section 3.

If the proposal is particularly complex and additional time is required this is charged at £149 (plus VAT) per hour.

Listed Building repair advice

This service is to confirm whether proposed works are a repair or require Listed Building Consent.

Response Type	Fee (incl. VAT)
Single meeting on site for up to 30	£446
minutes relation to one proposal only
