

Fees for Planning Services from Mid- year 2025

Pre-application advice

1. Householder pre-application advice.

Householder developments include extensions to existing houses, conservatories, loft conversions etc.

The fees are dependent on the type of response wanted;

Written response and a 30 minute meeting at the	£345

Written response and a 30 minute meeting on site	£413

If the proposal is particularly complex and additional time is required this is charged at £139 per hour.

2. Non-householder pre-application advice

Non- householder advice is for commercial properties or new or replacement residential dwellings

Minor developments – the below fee covers one meeting and one written response.

Major developments – the below fee covers

26- 49 dwellings	£7240
50+ dwellings	Bespoke fee or PPA to be discussed
1000+ sqm	Bespoke fee or PPA to be discussed

3. Specialist Advice- i.e. Conservation, Trees

This fee may be required in addition to the fees outlined above.

If the proposal is particularly complex and additional time is required this is charged at £149 (plus VAT) per hour.

This service is to confirm whether proposed works are a repair or require Listed Building Consent.
