1 Introduction

What is an Infrastructure Funding Statement?

- 1.1 This Infrastructure Funding Statement (IFS) presents information on developer contributions secured through section 106 planning obligations. It includes information on contributions secured, received, allocated or spent in the reporting year 1 April 2024 to 31 March 2025.

What are developer contributions and section 106 planning obligations?

- 1.2 Developer contributions can be financial payments towards off-site infrastructure improvements, or they can be provided directly by the developer, usually on-site, for example affordable homes, open space or a new school.
- 1.3 A section 106 planning obligation is a legal agreement entered into under section 106 of the Town and Country Planning Act 1990 to mitigate the impacts of a development proposal. Strict rules apply to planning obligations to ensure that permissions cannot be bought or sold. They must be:
- a) necessary to make the development the development acceptable in planning terms,
 - b) directly related to the development, and
 - c) fairly and reasonably related in scale and kind to the development.
- 1.4 A number of policies in the [Hart Local Plan \(Strategy and Sites\) 2032](#) are used to secure infrastructure improvements through planning obligations.
- 1.5 The Council's [Corporate Plan 2023/2027](#) states that the Council will *“Ensure an effective and transparent planning service, holding developers and our delivery partners accountable for providing infrastructure and affordable housing.”*
- 1.6 Further information regarding planning obligations is set out in the [National Planning Policy Framework 2024](#) and national [Planning Practice Guidance](#).

Who spends developer contributions?

- 1.7 Some financial contributions are spent by Hart District Council, including district leisure and affordable housing. Others are transferred to other organisations, primarily:
- Hampshire County Council (HCC) e.g. for education and transport. HCC produces its own IFS each year.

- Town and Parish Councils, notably for open space and leisure. Parishes request the money from Hart District Council to spend on appropriate local projects.
- 1.8 Depending on what the developer contribution is for contributions can be transferred to other organisations such as those that deliver health care services.

Thames Basin Heaths Special Protection Area

- 1.9 In Hart, planning obligations are sometimes used to secure SANG (Suitable Alternative Natural Greenspace) and SAMM (Strategic Access Management and Monitoring). These are avoidance and mitigation measures needed to protect the Thames Basin Heaths Special Protection Area from the impacts of additional recreation on the SPA (see Policy NBE3 Thames Basin Heaths Special Protection Area in the [Hart Local Plan \(Strategy and Sites\) 2032](#) and the Council's [Planning Guidance](#) page). Contributions to SANG and SAMM secured through planning obligations are reported in this document.

Community Infrastructure Levy

- 1.10 The Council does not currently charge CIL on new developments, and so this IFS does not refer to CIL receipts. The Council did consult on a Preliminary Draft CIL Charging Schedule in winter 2021 but decided not to continue with a CIL in light of proposals to introduce a new Infrastructure Levy through the Levelling Up and Regeneration Bill (although more recently the new Government has stated it does not intend to implement the Infrastructure Levy).

Financial amounts reported in this statement

- 1.11 The amounts of money referred to in this IFS take the following into account:
- All figures expressed in the document are net of any monitoring fees or charges. Typically, the Council receives 5% of the value of the contribution in fees for the work undertaken to ensure that the planning applications are implemented in accordance with the signed agreements and any planning conditions.
 - Most contributions are indexed linked to ensure that they reflect current values when collected with the relevant index being outlined in the agreement. In most cases the indexes used are set by the Building Cost Information Service.

- Section 106 Agreements are also subject to interest for late payments this is typically applied at four per cent above the Bank of England base lending rate.

2 Report on section 106 contributions

- 2.1 This IFS reports on the matters set out at [Schedule 2 of the Community Infrastructure Levy Regulations 2019 \(as amended\)](#) concerning contributions secured, received, allocated or spent in the reporting year 1 April 2024 to 31 March 2025.

1) The total amount of money to be provided under any planning obligations which were entered into during 2024/25

Total £174,349.46 (from eight S106 agreements) comprising:

- £46,570.00 in highways contributions
- £20,983.46 in SAMM contributions
- £106,796.00 towards the approval and monitoring of travel plans

2) Non-monetary contributions to be provided under planning obligations which were entered into during 2024/25

- 0.4224 ha of existing SANG land purchased by developers, secured through section 106, to mitigate the impact of their development on the Thames Basin Heaths Special Protection Area.

- £4,159,130.56 for off-site affordable housing
- £1,519,364.63 towards district leisure and open spaces

- £622,017.76 in highways contributions
- £79,391.28 in contributions towards town centre improvements
- £1,681.56 in SAMM contributions

Total £1,856,833.20 comprising:

- £506,067.94 allocated to district leisure and open space projects
- £1,044,000.00 allocated to affordable housing projects
- £305,772.76 allocated to parish leisure and open space projects
- £992.50 allocated to highways projects.

Total £3,538,812.81 comprising:

- £1,500,000.00 on the provision of affordable housing in the district

- £12,949.17 for parish leisure and open spaces projects

- £8,056.72 for ongoing maintenance of open spaces and play areas
- £122,551.74 SAMM in contributions - transferred to Hampshire County Council
- £1,190,590.04 in education contributions - transferred to Hampshire County Council
- £13,896.43 in highways contributions - transferred to Hampshire County Council
