Heading of 'Inclusive' states 'Provide sufficient affordable housing. Paragraph 39 states '17 policy areas for further investigation' and one area is 'policy in favour of generous provision of affordable housing'. Affect of Hart Local Plan makes any 'investigation' specifically for affordable housing within Yateley irrelevant because cannot deliver affordable homes. Local Plan permits affordable housing on developments of ten or more homes or sites of 0.5 hectares or more size. It appears Neighbourhood Plan contradicts itself as in Paragraph 23: Hart Local Plan Strategy and Sites 2014-2032 which states 'There is no specific housing allocat! ion for Yateley Parish'. Statements suggesting much needed affordable housing within Yateley will be investigated for sufficient supply and generous provision in policy, contradict affect of Hart Local Plan.
